Pay Your Dues and Donate on PayPal

MANDATORY COLD WEATHER LIFE JACKET WEAR

November 1 through April 30

Cold water shock is a major factor in boating fatalities when water temperatures are less than 70 degrees F. Cold water shock causes an involuntary gasp (often resulting in aspiration of water), hyperventilation, breathlessness and a reduced ability to control breathing and swim. A life jacket greatly increases your chance for survival in cold water. It also increases the amount of time for you to be rescued.

A disproportionate number of fatalities occur during the months of November through April. Coldwater immersion is one of the primary reasons for these fatalities, based on Pennsylvania's boating accident data. That's why the chance of a boating accident resulting in a fatality is significantly higher from November through April than during the rest of the year.




Waterfowl hunters in small boats are at a greater risk. While hunting, you often reach overboard while setting or retrieving decoys, retrieving downed game, and may have dogs entering and exiting your boat. Worse yet, you may stand or move quickly in the heat of the hunt. Any of these activities may result in an unexpected fall overboard.

Boat stability is also an issue for anglers. Leaning over the side of the boat to net a trophy, or standing to fight a feisty fish can be enough to capsize a small boat or canoe. Be safe out on the water!

Covid-19 and White-Tailed Deer



The United States Department of Agriculture (USDA) and Cornell University published research in May 2021 that demonstrated that in a laboratory setting, white-tailed deer are susceptible to SARS-CoV-2, can shed the virus in nasal secretions and infect other deer, and can develop SARS-CoV-2 antibodies following infection. All infected deer were subclinical, that is, they showed no observable signs of disease. The USDA then analyzed blood that had been collected over several years from wild white

-tailed deer in Illinois, Michigan, New York, and Pennsylvania. While SARS-Cov-2 antibodies weren't detected in any samples

from the pre-pandemic period (i.e., prior to 2020), antibodies were detected in 40% of the total samples from 2021, which demonstrated that wild deer were exposed to the virus and mounted an immune response. More recently, the USDA has detected the SARS-CoV-2 virus in wild white-tailed deer in Ohio, and research conducted of captive and wild white-tailed deer in Iowa detected multiple spillovers of SARS-CoV-2.



What can you do to stay safe? Leaving wildlife wild and avoiding contact is the best way to protect yourself and wildlife. While there is no evidence that deer can spread SARS-CoV-2 to humans, wildlife may carry other diseases that can spread to humans and domestic animals. For wildlife biologists, rehabilitators, hunters, and others who cannot avoid contacting wildlife, it is important to practice good hygiene by wearing disposable gloves, and when appropriate, masks or other personal protective equipment. Don't touch your face, eat, drink or smoke while handling any wildlife. Always use soap and water to wash your hands and any equipment tools, or surfaces that contacted wildlife. Equipment, tools or surfaces can then be disinfected with a 10% bleach solution for a minimum 10-minute contact time before rinsing with clean water and allowing to air dry. Always ensure that wild game meat is cooked to the proper internal temperature.


Wildlife crimes affect everyone. Poachers are thieves, help us catch them!
